There was a success rate of approximately 10%.

- (i) 43 appeals were lodged parents/carers
- (ii) 2 appeals were cancelled by parents/carers
- (iii) 41 appeals were heard by the Independent Appeal Panel
- (iv) 37 appeals were dismissed (were not successful)
- (v) 4 appeals were upheld (were successful)

2020

There was a success rate of approximately 14%.

- (i) 53 appeals were lodged by parents/carers
- (ii) 2 appeals were cancelled by parents/carers
- (iii) 51 appeals were heard by the Independent Appeal Panel
- (iv) 44 appeals were dismissed (were not successful)
- (v) 7 appeals were upheld (were successful)
