There was a success rate of approximately 9%.

- (i) 38 appeals were lodged parents/carers
- (ii) 3 appeals were cancelled by parents/carers
- (iii) 35 appeals were heard by the Independent Appeal Panel
- (iv) 32 appeals were dismissed (were not successful)
- (v) 3 appeals were upheld (were successful)

2021

There was a success rate of approximately 10%.

- (vi) 43 appeals were lodged parents/carers
- (vii) 2 appeals were cancelled by parents/carers
- (viii) 41 appeals were heard by the Independent Appeal Panel
- (ix) 37 appeals were dismissed (were not successful)
- (x) 4 appeals were upheld (were successful)
