There was a success rate of approximately 19%.

- (iv) 25 appeals were dismissed (were not successful)
- (v) 6 appeals were upheld (were successful)

2022

There was a success rate of approximately 9%.

- (viii) 35 appeals were heard by the Independent Appeal Panel
